- **Do not** submit the form to the Ohio Department of Education.
- Your provider will let you know if you qualify

⇒ **Online registration needs to be completed prior to attending (One View). If student is returning from 2020-2021 school year only complete the emergency medical form and any changed information (ex. address, phone etc.) Any changes, ex: phone number, address etc. you must change in One View and let the building secretary know.**

⇒ **The following needs to be brought to the Preschool BEFORE your child can attend his/her first day!!!**

- Completed Physical Evaluaton (this form is valid for 13 months)
- Dental Form (we have the mobile dentist coming in October)
- A copy of your child's immunization record.
- Birth Certificate (copy, we can make a copy at the school)
- Social Security Card (copy, we can make a copy at the school)
- Proof of Residency (copy of gas bill, water bill, electric bill etc., this can be left in the envelope for us to run a copy)
- Child Release Authorization (3 Emergency contacts from One View must be on this list)
- Classroom Form for Teachers
- Language Usage Survey (If this is your child's first year)

⇒ **Tuition is due by September 13<sup>th</sup>, 2021.**
